PROPAGATION REPORT Paul Drexler, W83JYO

Propagation during the past month has started to perk up from its lower than normal activity. Six opened up to the W and SW several times during the month including the evening of the 3lst. There was enhanced propagation to the Ohio and Michigan areas on 2 meters notably on the evenings of May 29th, 30th, and 3lst. On the 3lst at 0100 GMT, K5SW (EM25) called me as I was signing with WA8CXI (EM99). Several other stations were briefly heard via Es although the band didn't really open up during the rest of the evening.

W3CCX went westward to FNØl for the June contest. Chairman Dave, N3CX had told us about the good QTH, but Dave didn't tell us that we were going to be treated with tropo, aurora, and Es! Six and two were alive for most of the weekend and 220 and 432 experienced some good tropo conditions as well. There was an aurora on 6 and 2 that lasted for over 3 hrs, starting at 1900 on the 10th! 25 new grids were worked on 2, and several grids on 220 during the aurora. The "buzz" was heard thru 432 for a short time. At 0500 to 0550 on the 11th an opening occurred to the Atlanta area on 2, 220, and 432, with EM54, EM55, EM64, EM75, and EM77 worked on 2. Scotty, WA3FFC put W3CCX on the moon with a QSO with W5UN (EL29) on 2 and DL9KR (JO40) on 432! Overall, weekend conditions on the lower frequencies were exceptional, but little exciting happened on 903 and above. Perhaps part of that can be attributed to the many stations unaware of our new location, in FNØl.

CONFLICT OF INTEREST? DE WESTLINK REPORT

Mimi Dawson, the now former FCC Commissioner, has joined the law firm of Wiley, Rein and Fielding. This is the same group of lawyers which is handling the lobbying effort for United Parcel Service in regard to the company's claim for need of spectrum for its digital/voice national dispatch system in the recently allocated 220 to 222 MHz. amateur radio band.

Although President Bush has not yet named a replacement for Dawson, one of the names which appears to be under consideration is Sherrie Marshall. Interestingly, Marshall is also currently an attorney with Wiley, Rein, and Fielding law firm. If Ms. Marshall is nominated and confirmed by the Senate, it would probably be a blow to the amateur community in the matters of retention of current spectrum allocations and in issues such as the recent reallocation of the lower 40% of the 220 band.

Further, it would make it difficult if not impossible for a three member Commission to effectively and impartially deal with the 87-14 reallocation forcing the FCC to go to a four member or full five member level to function on this issue.

ARRL TO FIGHT NEW PART 15 RULES DE W5YI REPORT

The ARRL is set to lock horns once again with the FCC's Office of Engineering and Technology. The ARRL's General Counsel, Chris Imlay, N3AKD, has filed both a strongly worded Petition for Reconsideration... and a Motion to Stay implementation of new Part 15 rules allowing unlicensed operation of RF devices in the amateur radio bands. The well done and documented submission runs to nearly fifty pages.

The FCC released their rewrite of the Part 15 Rules on April 18, 1989. RF devices operating under Part 15 include unintentional radiators (such as computers, video/radio products and other appliances) and intentional low-power transmitters such as cordless telephones, garage door openers, security devices, baby monitors, remote control toys... and the like.

The League argues:

- 1). The FCC ignored the engineering data, relied on inaccurate assumptions ... and drew "erroneous conclusions from claimed experience which in fact it does not have." New engineering data was included with the ARRL Petition for Reconsideration.
- 2). The Commission ignored the hundreds of amateurs' comments discussing the interference potential of Part 15 devices. Referring to the recent reallocation of the 220-222 MHz band by the same agency, the League charges: "This is the second time in recent months that the Commission has virtually ignored large volumes of amateur comments in rule making proceedings."
- 3). The FCC should not have permitted new, high powered Part 15 devices on amateur bands 902 MHz and above.
- 4). The FCC "should have, consistent with the intent of the Communications Amendments Act of 1982, required manufacturers of RF-susceptible home electronics equipment to provide RFI resolution information in the owner's or user's manuals for the devices, as well as a contact point for consumer RFI information.
- 5). The FCC should have placed the amateur bands in the list of "protected frequencies". Only certain government and aviation bands were restricted from Part 15 operation.

Since the devices may be produced and sold after June 23, 1989, the League said it is urgent that implementation of the new Part 15 Rules be immediately delayed until all administrative and judicial appeals are exhausted. "Absent a stay, manufacturers will produce and sell the devices to consumers, which cannot be retrieved thereafter." The ARRL maintains that the Commission has no findings to counter their technical report which clearly establishes the severe interference potential of any increase in permitted RF emission levels from Part 15 devices.

The League's primary argument is that the interests of the American consumer have been completely disregarded, in favor of the manufacturer of these devices ...since such devices are not subject to protection from interference from licensed radio services. The ARRL contends that the FCC has created a situation whereby electronic products radiating under Part 15 rules can be rendered useless by the presence of nearby authorized signals.

"The Commission relies solely on its rule that Part 15 devices must accept interference from licensed radio services and must not cause such interference. The cannot be comforted by this 'wave of the hand', however, when his device does not work as a result of the interference. The Commission cannot be relied upon to protect the licensed radio operator from interference from Part 15 devices because it has no resources with which to investigate and resolve these problems."

"The Commission has assigned large numbers of amateurs ...and millions of American consumers an interference burden that they cannot and should not be expected to accept" A stay will prevent damage to the consumer and to the amateur radio operators until the Report and Order can be substantively revised.

It's all new now... new style ham plates, and some other things to come. The new plate features the inscription "AMATEUR RADIO OPERATOR" along the top edge, above the callsign. To get them:

- 1. You may order by mail; obtain a MV900 or MV904 form ...complete and mail to PennDoT, Harrisburg... or -
- 2. You may obtain direct, completely persoalized and expedited service by sending information to K3TX, PO Box 224, Morrisville, Pa 19067. 215-946-1040 Condition 1: Auto is presently registered to the amateur and does have a call-letter plate -- make photo-copy or trace of plate, photo-copy of current registration card, amateur license, and insurance card, and send these with check for \$23 payable to "Liberty Auto Tags" to K3TX.
- Condition 2: The current plate does not have call-letters -- omit the copy of current plate and send the other items to K3TX.
- Condition 3: Registration is about to expire in the next 3 months. We can renew overnight. Please don't try to get a ham plate by mail near renewal time. It won't work.
- Condition 4: Car is not presently registered at all, or not registered to the amateur -- call or write K3TX.
- Special Note: If you have a Ø callsign, do not attempt to order ham plates other than through K3TX.
- Presently, only one ham plate to a customer. We hope to soon have available plates such as K3TX-2, K3TX-3 etc.


