- 1- Matt first came into the club in July of 1956, two months after the club was formed. Three years and two weeks later we received his call as a club call.
- 2- On July 13th we received a letter from the secretary of the FCC requesting a copy of the Constitution and By-Laws, Matt's current license and proof that he was a member before he passed away.

  Matt was club member number 13.
- 3- Matt was a Chief Officer (I don't remember whether it was Petty or Radio) in the Navy, and the first time his call was used as a club call, was Maritime on the boat trip the weekend of July 31st to August 2nd.

Since Matt joined the club before we had applications, the only way we could prove his membership was to send the FCC the 1957 membership list and the attendance records from July 1957 to June of 1958. Mrs. Gelardi found his membership cards, so we also sent them along. All of the information was mailed on July 23rd and just one week later we received the call, plus the return of all papers sent ip.


We would like to take this opportunity to thank Carmen Gelardi, Matt's widow, for her wonderful co-operation in this matter.

#### REPORT OF CRUISE OF JUNEBUG IV by W3SAO

JUNEBUG IV -- 45' Cabin Cruiser Beam 13'6" Twin screws and 165 HP motors 9" blades on props Draft 3' Cruising speed 22 knots perhour.

Left Croydon at 2335 July 31st. Due to heavy fog we were forced to seek shelter  $\frac{1}{2}$  mile north of Delaware Memorial Eridge from 0430 to 0600.

When we went o make coffee, we found that there was a leak at the Propane Gastank; no gas - no coffee. Stopped at Chesapeake City for new container.

Stopped at Wharton Creek, Maryland for gas for motors.

Went swimming at Belly Button Beach, Maryland. K38GT, Harvey, walked on a broken bottle and cut the pad of his big toe on the left foot. Doc looked at it and decided that it needed hospital attention. Doc put a tourniquet on it, and we took him to Chester Town Hospital. There they gave him a tetinus shot and sewed it inside and outside. Seems he cut an artery and four veins. He is doing DK.

Storm clouds forced us to up-anchor at 1900 and head for Ordinary Point, on Sassafras River. Most of the crew slept on deck due to the heat.

Upped-anchor at O600 Sunday, August 2nd and headed for home. Rough weather all the way home. Heavy winds and river.

Anchored at Port Richmond at 1400 to have a chance to work 2 and 6 meters without motor interference. Ignition interference was 20 db over 9. Had a ball working the fellows while anchored there. In Maryland we only worked one station. Home at 1822.

Our good captain, Harry Bryan still had as much hair when we returned as he did when we left. He said that for a bunch of "landlubbers" we made a pretty good crew.

W3FSC, Ossie, was the cook, and even though we hate to admit it, he is a very good one. No one got sick from it, and no one got seasick.

145-147 MC. OPENED BY FCC TO TECHNI-CIAN-AMATEURS STARTING AUG. 21st.

Finalizing Docket 12728 in mid-July, nets, and there should be a better the FCC granted the central half of chance to develop AREC and RACES set the 2-meter band to techs, This grant ups, with the assistance of ECs, ROs is effective from Aug. 21, 1959 as will and Ass't ECs (for Ecs may place one be mentioned in September QST, in each frequency band group).

FCC mentions with its REPORT AND ORDER that it got a large number of comments on this docket, both for and against. The Commission cites ARRL's filing, then lists 12 main reasons advanced by various parties "for" 144-148 Mc. assignment to Technicians followed by seven counter arguments. The Commission states that it evaluated the soundness of each 'reason' and then tabulates findings in support of its action.

Among these findings FCC lists (1) the usefulness of the band for Civil Defense and Emergency communication over short and medium ranges (2) that two meters is the ONLY area in which technicians and Novices can intercommunicate (3)that some opening of this band to Techs. will tend to more evenly distribute activity in the v.h.f. bands, aswell as promote occupancy (in more than just metropolitan areas)

FCC found merit in the opposition comments suggesting that less than the full band be allocated for Technician operation. We quote. "The reasons given (FCC) were related to the belief that opening the whole band to Technicians would decrease the incentive of these amateurs (a) to experiment with and develop the higher portions of the spectrum, and (b) also decrease the incentive to increase their code speed, with the intent to advance to General Class licensees. It was then with the idea of RETAINING SOME OF THE INCENT-IVE to work for full amateur privileges the FCC felt it could not go all the way. FCC further said,"...the 145-147 Mc. segment... is a resonable choice...it would permit Tech, and Novice to intercommunicate on the same band using voice or telegraphy: the two classes could take advantage of this FOR THE PURPOSE OF INCREASING THEIR CODE SPEED AND HENCE FORTH QUALIFYING FOR GENERAL CLASS PRIVILEGES: it would result in the least disruption of Ganeral Class licensees who are using specific segments of the band"

From Communications Mgr. Cont'd RADIO CLUES AND SCM'S --- NEW CHALLENGE AND OPPORTUNITY IN PRECEDING

There are, we think, new organizational implications, opportunities and significance in the operational and occupancy changes that will follow from the preceding action. Clubs that bave had membership grounings that s able to use ALL BANDS and those limited to Technician frequencies, should now find a greater common denominator for the groups to work together. With increased manpower better local-net coverage and bigger turnouts for on the air tests should be assured. two and six meter bands afford practical means for stand-by radio emerency nets, and there should be a better chance to develop AREC and RACES set ups, with the assistance of ECs, ROs,

V.H.F. Nets besides purely locals that have better section coverage (and interchange connections from member stations freely working more than one band and connections with section nets on other frequencies) also should be encouraged and fostered by SCM's and Clubs. After appropriate study, we hope SCM's will help promote such continuing v.h.f. net groups, by appointing Phone Activities Managers with this special objective.

Until such time 49 states only will qualify for WAS certificate. A grace period eill be allowed for 49 state WAS after Hawaii is proclaimed a state.

TO ALL RADIO AMATEURS BT

The radiation of harmonics from amateur stations in the 7.4 and 11 Mc or other frequency ranges outside the amateur bands continues to invite FCC notices. Amateurs, especially those newly licensed, are urged to check and make sure their transmitters and antennas radiate at the desired output frequency and not at any harmonic. A check with a general coverage receiver by an assisting amateur close by is recommended to locate such faults. The antenna coupler described in August 1958 QST and Chapter 23 in the Radio Amateur's Handbook are an aid to initiationg corrective measures.

LENGTHY IMPORTANT PROCEEDING

The residual season and the control of the control

The FCC has just completed its allimportant hearings into the allocation of and use of frequencies in the 25-890 MC portion of the spectrum. This will provide the blueprint for its delineation of the spectrum apportionment and usage for the vast array of radio services. These services range from FM broadcasting and TV and tropospheric scatter of activities including policefire services, petroleum, telephone companies, utilities, manufacturers, rail-taxi-trucking transportation, and highway construction and maintenance. Analysis of the requirements and positions of the 60-odd organizations and companies, presented in written and oral form with cross-examination only by the FCC Commissioners and staff, will be a tremendous task. It will take months for determinations to be promulgated.

I know that I stated in the last issue that this one would be late, but so much information has come in that I am putting it out before vacation time.

### ARE YOU LICENSED TO MAIM AND KILL?

Perhaps you will feel that this does not belong in "Choose Sits" as it has nothing to do with Ham Radio, but it does apply to you whether you are a ham or not, just so long as you have a license to drive a car.

You can read, you see it in the paper everyday, the flagerant disregard of the law where motor vehicles are concerned; droving through stop signs and red lights, failure to give way to the pedestrian, blocking the intersection, illegal parking, hit and run accidents and illegal operation of a car.

From my own experience I can state a few incidences.

1- DRIVING THROUGH RED LIGHTS

From my QTH, I see everyday, drivers who see the yellow light one block away and refuse to slow down, When they reach the corner they have to slam on their brakes, and nine times out of ten, they are half way across the intersection before they stop. If you don't know our location; we are located in the center of a "T" crossing, which means that all cars must turn, stop or hit the house

2-FAILURE TO GIVE WAY TO THE PEDES-TRIAN

Before traffic lights were placed at our corner it was a wonderful experience to get across the street. Onetime during a snow storm, I stood on the corner with a baby in my arms, and if it hadn't been for a truck driver pulling into the intersection, and blocking traffic, I wouldn't have gotten across. Our location is also two blocks away from a school, and each morning I see the drivers make the children stand on the corner and wait just because they must make the turn. If the children have started to cross the street they force them back. I am not in sympathy with the Jaywalker, but with the pedestrian trying to cross at the intersection.

3- BLOCKING THE INTERSECTION

I can understand this at blind corners, the driver must pull up to see if anything is coming the other way, but where there are traffic lights, there is no excuse for it.

4- ILLEGAL PARKING

I see this everyday with the trucks making delivery to the store across the street. They park the wrong way and right up to the corner. To cross the street you must walk into oncoming traffic.

5- HIT AND RUN ACCIDENTS

Thank God I have not had any experience with these. I can understand a driver panicing and leaving the scene, but then returning later and giving himself up to the police, that is a natural reaction, but the driver who leaves and then hides, I can't understand. Where is his moral sense of responsibility? He would be the

In my opinion and a lot of you will not agree with me, a person that kills another person in a hit and run accident is a murderer. True, it is not premeditated, but he did take a life that did not belong to him, and failed in his duty to God and man to own up to his responsibility.

6- ILLEGAL OPERATION OF A CAR This I have had experience with. The first time I took the car out by myself, a driver blew to pass me. was fine, but he pawsed me on the right, and had I automatically pulled to the right, I would have pulled into him. Had I hit him, he would have blamed me, even though he was in the wrong.

Until you came to article no. 6. I am sure you figured that I was merely a passanger. Now you can see why I do not drive unless it is absolutely necessary.

What prompted this tyrade on safe driving follows.

An entire family of amplifiers and oscillators designed to operate over different portions of the spectrum is being sired by successful research efforts with the maser.

Most work in this neo-maser area is primarily of a theoretical nature, but several scientists involved in research studies have expressed the belief that it is only a matter of time until prototypes are built and operated.

Like the maser these will be quantum mechanical devices and will bear names similar to that of the maser with only the first letter or letters will be changed to designate the frequency range over which the device will operate.

Thus, just as maser is an acronym for microwave amplification by stimulated emission of radiation. raser stands for radio frequency amplification, laser-light amplification, and iraser-infrared amplification.

It seems that not only hams are troubled with interference. In a seminar just concluded the urgent need was for radical advances in RF interference control, as well as better instruments and and standards for interference measurements.
